PLANNING COMMISSION: Chairman John Delmotte reported that the subcommittee has met three times, they are working on a number of issues and will report to the Planning Commission at the February 21st meeting.

LMR: Trustee Henderson reported on the last meeting held January 21st, Mark Manor did a great job on the year end report, there was a nice write up in the Monroe evening news with all the statistics. It was stated that the LMR saved money on radios because of the 911 proposal approval on the November 2018 ballot. LMR is always looking for new members. CITIZEN COMMENT TIME: John Delmotte had questions on the dirt pile on M-50, and asked about getting work done on Eggert Rd. Gary Busenbark asked who selects the type and size of stone used on the Township roads.

BOARD COMMENT TIME: Supervisor Blanchette stated that Miller Development wants to put a business in one of the existing buildings, the information was sent to Our attorney and our planner for review, it was also mentioned that Miller needs to finish up and meet all the requirements from the final site plan. Trustee Woelmer responded that he believes that there are no manufacturing facilities there now, and his understanding is Miller has to come to the Planning Commission for each review that is not manufacturing. Clerk Fetterly gave a report on results of the State of Michigan Election Audit she had on January 10th 2019. There were approximately 76 questions and items they reviewed. The results stated Overall things were in very good shape.
