MOTION by Treasure Meyer, **SUPPORTED** by Clerk Fetterly to allocate 5 commercial sewer taps to parcel # 58 13 128 111 00 and 5 commercial sewer taps to parcel # 58 13 127 318 00 with the condition that before we would allow use of any of those allocated 5 taps the property owner would be required to sign something accepting that and waiving any right to claim additional taps in the future. **MOTION CARRIED.**
