*TREASURER REPORT:* **MOTION** by Trustee Henderson, **Supported** by Trustee Woelmer to approve the treasurer report. **Motion Carried.**

*BUILDING DEPARTMENT REPORT:* There were 35 permits issued for the month of August There were 15 building permits, 5 electrical, 12 mechanical and 3 plumbing for a total fee of \$4,648.00

*BILLS:* **MOTION** by Trustee Henderson, **Supported** by Treasurer Meyer to approve the bills for this month. **Motion Carried.**

*OLD BUSINESS:* Supervisor Blanchette stated that Gabby's Ladder had a few concerns and questions about the purchase of the township property.

*NEW BUSINESS:*

*BLIGHT REPORT:* There were two blight complaints, one for high grass and weeds on N Raisinville Rd and for blight on Stewart Rd. The owners have been sent a letter.

Jim Ross representing the MCCC asked to be put on the agenda to discuss the College millage on the upcoming November election. Mr. Ross gave a great explanation on the need to update and improve many buildings at the college.

Treasure Meyer stated that she has been working with our bonding agency and has permission to pay off the bonds and expenses for the Cherry/Dixon Water District, She needs permission to send a letter to Monroe Bank & Trust stating that the Township will be paying off these bonds. **MOTION** By Supervisor Blanchette, **Supported** by Trustee Henderson to send a letter to MB&T stating our intent, **Motion Carried.**

The Township Board discussed options on notifying residents of a survey for the updating of the Township master plan. **MOTION** By Trustee Woelmer, **Supported** By Trustee Henderson that the Township Board give power to the Planning Commission to approve the survey and to use the voter file to mail out post cards and to have the survey available on our website **Motion Carried.**

**MOTION** By Trustee Henderson, **Supported** By Treasure Meyer to approve a resolution showing support for Crystal Waters Land Acquisition **Motion Carried** 4-yays 0-nays 1 absent.
