The Raisinville Township Board meeting was opened with the Pledge to the American Flag.

MINUTES: **MOTION** by Trustee Henderson, **Supported** by Treasurer Meyer to approve the minutes of the November 3rd, 2015 board meetings. **Motion Carried**

TREASURER REPORT: **MOTION** by Clerk Fetterly, **Supported** by Trustee Henderson to approve the treasurer report. **Motion Carried.**

BUILDING DEPARTMENT REPORT: There were 47 permits issued for the month of November. There were 32 building permits, 7 electrical, 6 mechanical and 2 plumbing for a total fee of \$5928.00.

BILLS: **MOTION** Trustee Henderson, **Supported** by Treasurer Meyer to approve the bills for this month. **Motion Carried.**

OLD BUSINESS: Supervisor Blanchette stated that the township Attorney is working on a purchase agreement with Gabby' Ladder to purchase the township owned property on S. Custer Rd, it should be ready soon. He also stated that Albain Road is done and painted.

NEW BUSINESS:

BLIGHT: Nothing this month.

Re-Appoint members to various Township boards: **MOTION** By Trustee Henderson, **supported** by Treasure Meyer to reappoint Michael Jaworski, Ann Nickel-Swinkey, and Craig Assenmacher for a 3 year term on the Planning Commission. **Motion Carried.**

MOTION By Treasure Meyer, **Supported** Clerk Fetterly to reappoint Mark Manor as an alternate to the Zoning Board of Appeals for a 3 year term. **Motion Carried.**

MOTION by Clerk Fetterly, **Supported** by Trustee Henderson to reappoint Patti Wartinger to the Library Board for a 3 year term. **Motion Carried.**

MOTION by Treasure Meyer to except a bid from JB Seal Coating to do the snow removal for the Township Hall for one year, **Supported** by Trustee Henderson. **Motion Carried.** The Township Board made a decision not to except, and sign a contract with Yard Master for the snow removal.

Chris Westover, from the Monroe County Health Department sent a letter requesting that the Township Board approve a resolution for a county wide plan for a Solid Waste Disposal Facility and Hauler Licensing Ordinance. The Board checked with the township attorney, and discovered that the County needs more than 67% of the townships to do such a resolution to be able to go forward with their plan at the state level. This really does not affect Raisinville Township since we do not have curb garbage pickup. **MOTION** By Trustee Henderson, **Supported** by Treasure Meyer to approve a resolution for the Monroe County Solid Waste Management Plan prepared under the requirement of PA 451 part 115. **ROLL CALL VOTE:** Supervisor Blanchette-Yes Treasure Meyer-Yes, Trustee Henderson-Yes, Clerk Fetterly-Yes, Trustee Woelmer –Absent. **Motion carried.**

Mannik & Smith submitted paperwork stating that they did a review to some landscaping plan changes with Miller Business Development Park (Buildings A & B) and found that the changes met the necessary requirements. **MOTION** By Trustee Henderson, **Supported** by Treasure Meyer to approve the site plan changes and request final site plan drawings reflecting the changes be resubmitted for signatures, according to the Township Engineer. **Motion Carried.**

PLANNING COMMISSION: The November meeting was canceled due to lack of agenda, and the December meeting is also canceled due to lack of agenda.

LMR- Trustee Henderson stated that the November meeting was canceled and the next meeting is scheduled for January 18th, 2016 at 7:00 pm.

CITIZEN COMMENT TIME: Resident Keith Siebarth stated that another township resident wanted to know what was being hauled in the “big metal tankers” going by her home. The Board was not aware of anything in that matter. Rick Smith wished the board a Happy Holiday Season.

BOARD COMMENT TIME: Supervisor Blanchette thanked the Township for the gift box he received after a recent back surgery, and also wished the Township and its residents a Happy Holiday Season.
