PLANNING COMMISSION: at the January 20th 2020 meeting election of officers was held- Chairman-John Delmotte, Vice Chair-Mike Jaworski, Secretary-Ann Nickel-Swinkey. The board also had a long discussion of proposed amendments to the Zoning Ordinance. The next meeting has been changed to February 10th 2020.

LMR: Election of officers were held at the January 20th 2020 meeting officers remained the same. President-Jill Martin, Vice President-Keith Henderson, Treasurer- Jean Grubb, Member at large-Frank Robinson. The fireboard also went over the budget to be presented to the townships. There are 18 members at LMR and 2 in training. Calls per jurisdiction for 2019 were Raisinville Twp-182, London-87, Maybee-39, Other (Mutual aid)-46. The next meeting will be March 16th 2020.

ZBA: Trustee Henderson stated that there was a public hearing and a motion to grant variance of 1,04 square feet above the current ordinance (for a 36x48 Building) and to remove shipping container. Motion approved 4-1
