Before the next item on the agenda PC Chairman John Delmotte stated that the Planning Commission members and the Township Planner had discussed about requesting a moratorium on the large-scale wind energy systems applications. Chairman Delmotte stated that they were in agreement that some items needed to be looked at in the current ordinance, and thought it would be good to review along with the large-scale solar ordinance, in no way did they want it to be a tool to block applications, just would like the time to review current items. The time line on the moratorium would coincide with the current solar panel mortarium.
