Supervisor gave a list of contracts from the MCRC to approve, we received ½ of our ARPA money that we were allowed to spend this year. **MOTION BY:** Trustee Jaworski, **SUPPORTED BY:** Trustee Woelmer to approved 11 contracts for this year's road work. **MOTION CARRIED.**

Supervisor Blanchette went through the LMR Budget line by line and showed us the increases that were necessary.
