BUILDING DEPARTMENT REPORT: There were 49 permits issued for the month of April (2 were canceled), there were 15 building permits (2 new houses), 10 electrical, 17 Mechanical and 5 plumbing, and 9 reinspection fees, for a total fee of \$9141.00.
