Margaret Dolezal of 7691 Dixon Rd asked to be on the agenda to discuss a noise ordinance. Ms. Dolezal gave an in-depth presentation on why Raisinville Township should add to our noise and public nuisance ordinance. A few surrounding neighbors also commented on the noise of some dirt bikes in the area. The Board took all the comments and concerns into consideration and asked the Planning Commission to look into updating and or changing the noise and public nuisance ordinances.
