The Township received bids on new flooring and shades to the Township Hall.

MOTION BY: Supervisor Blanchette, **SUPPORTED BY:** Treasurer Meyer to approve a Budget amendment to the current Budget in the election department for 10,000.00 to cover the May school election. **MOTION CARRIED.**

The Township received invoices from The Mechanical inspector for classes and expenses for the last three years. The Township Board had discussions with our auditor and attorney and other township Clerks.

MOTION BY: Supervisor Blanchette, **SUPPORTED BY:** to approve to pay the inspector for classes only for this budget year. **MOTION CARRIED.**
