SPECIAL BOARD MEETING
MINUTES

The Raisinville Township Board meeting was opened with the Pledge to the American Flag.

MINUTES: **MOTION BY** Trustee Woelmer **SUPPORTED BY** Treasurer Meyer to approve the minutes from the April 4th 2023 township board meeting **MOTION CARRIED.**

TREASURER REPORT: **MOTION BY** Clerk Fetterly **SUPPORTED BY** Trustee Woelmer on to approve the treasurer report. **MOTION CARRIED.**

BUILDING DEPARTMENT REPORT: There were 25 permits issued for the month of April there were 6 building permits, (2 new homes) 6 electrical, 11 mechanical and 2 plumbing, 2 reinspection fees for a total fee of \$ 4129.00

BILLS: **MOTION BY** Supervisor Blanchette, **SUPPORTED BY** Trustee Woelmer to approve the bills for this month, with the increase to the hall painting bid. **MOTION CARRIED.**

OLD BUSINESS: Supervisor Blanchette stated that the tire recycling day went pretty well. The Township paid \$1845.00 over the grant money of \$6,000.00.

Supervisor Blanchette let the Board know of an increase to the W. Dunbar Road project, he was able to get the increase down within the 10% overage agreement in the original signed contract, so no further action needed by the Board.

NEW BUSINESS:

Sherriff Goodnough was here and gave a report and a break down to the number of calls that were made in Raisinville Township last year.

The Township Board discussed two issues from the building department. 1) The Board is giving the Ok to the Building official to allow Bob & Shery Paducha at 4320 S Custer Rd to be able to have a travel trailer on the property while building a new home. If they plan to live in it, it will have to be hooked into the septic system per the current ordinance. 2) The Township Board agreed to allow Tom Johnson of N. Raisinville RD to leave his storage containers on the property until 12-31-2023.

PLANNING COMMISSION: Trustee Woelmer gave a report on the April 17th meeting, they discussed the recent survey results, and the master plan. Next meeting will be May 15th, 2023 at 7:00 PM.
